Cover overview "Medical expenses and repatriation"

This cover overview will only apply if the insurance policy schedule expressly shows that the "Medical expenses and repatriation module" has been included under the policy.

Applicable coverage

Medical expenses:

- medical and emergency dental care expenses;
- (helicopter) emergency transport;
- repatriation;
- vaccination (limited).

Costs of repatriation after death or funeral/burial costs at the place where the seafarer died

The rendering of assistance in case of:

- illness and accident;
- loss of life.

The costs of a travel ticket:

- in case of an unexpected recall of the insured person to his or her homeland;
- in the event of sending a relief seafarer or replacement in case of serious illness, accident, loss of life and unexpected recall;
- of family members in the event that the insured person is admitted into a hospital outside his or her homeland. Accommodation expenses of this family members are also covered.

Terms and Conditions

Anker will only reimburse the above mentioned costs and expenses when expressly mentioned in the Terms and Conditions of the policy and when no exclusions apply.
