## Clause(s)

### **2 - Rating paralysed due to illness**

In addition to the cover Permanent Disability there is coverage if the rating is detached from the vessel due to illness and during the medical treatment, in the recovery period up to six months, the rating becomes paralysed.

The rating receives 10% from USD 40,000.

### **6 - Medical expenses homeland - limited**

In derogation of article 13.1 it has been agreed that this module will not provide any cover if the expenses incurred as a result of an accident or job-related injury or job-related illness, which is considered equivalent to an accident, are recoverable from another insurance or pursuant to a social security scheme or statutory regulation. Job-related illnesses are understood to be diseases contracted in connection with the employment and which are considered equivalent to an accident during the employment. These illnesses are specified in a list laid down by Dutch law.

## Cover overview "Medical expenses and repatriation"

---

This cover overview will only apply if the insurance policy schedule expressly shows that the "Medical expenses and repatriation module" has been included under the policy.

### Applicable coverage

#### Medical expenses:

- medical and emergency dental care expenses;
- (helicopter) emergency transport;
- repatriation;
- vaccination (limited).

#### Costs of repatriation after death or funeral/burial costs at the place where the seafarer died

#### The rendering of assistance in case of:

- illness and accident;
- loss of life.

#### The costs of a travel ticket:

- in case of an unexpected recall of the insured person to his or her homeland;
- in the event of sending a relief seafarer or replacement in case of serious illness, accident, loss of life and unexpected recall;
- of family members in the event that the insured person is admitted into a hospital outside his or her homeland. Accommodation expenses of this family members are also covered.

#### Loss of equipment due to a shipping disaster
